## Parents Code of Conduct

I, as a parent of a youth sport participant, agree to the following rules and regulations set forth by the East Hanover and Florham Park Recreation Departments.

- I will not force my child to participate in sports.
- I will remember that the game is for the children, not the adults.
- I will inform the coach of any physical disability or ailment that may affect the safety of my child and the safety of others.
- I will learn the rules of the game and the policy of the league.
- I will be a positive role model for my child and encourage sportsmanship by showing respect and courtesy, and by demonstrating positive support for all players, coaches, officials and spectators at every game and practice.
- I will not engage in any kind of unsportsmanlike conduct with any official, coach, player or parent, such as booing, taunting, profanity language or gestures.
- I will teach my child to resolve conflicts without resorting to hostility or violence.
- I will never ridicule or yell at my child or other participants for making a mistake or losing a competition.
- I will respect the officials and their authority during games and will never question, or confront coaches at the game field/gym.
- I will refrain from coaching my child or other players during the games and practices, unless I am one of the official coaches of the team.
- I understand that practices are mandatory, and there is no missing practice to participate in club wrestling unless approved prior by the head coach only.

I agree to abide by all rules and policies as set forth by East Hanover and Florham Park Recreation Departments. I also understand, if I violate any of the rules or policies, I will be on probation for the following year.
