PUBLIC INPUT:

- 1. Ronna Gruskin, 48 Castle Ridge Drive, voiced traffic safety concerns near the Daycare office building being constructed on River Road across from Castle Ridge Townhomes. She suggested that the rear of the property be used to access and exit in order to relieve the traffic flow onto River Road.
