# Public Hearing: Ordinance No. 7-2017~ Amend and Supplement Chapter 201, Sanitation; Prohibited Nuisances

The Clerk announced that she had Ordinance No. 7-2017, entitled "AN ORDINANCE OF THE TOWNSHIP OF EAST HANOVER, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING THE TOWNSHIP CODE CHAPTER 201 SANITATION, SECTION §201-2 PROHIBITED NUISANCES, SUBSECTION B, TO ADD A NEW NUMBER (16) TO PROHIBIT URINATING OR DEFECATING IN PUBLIC."

The Mayor stated they would now hold a public hearing on Ordinance No. 7-2017.

The Mayor advised that Ordinance No. 7-2017 has been duly adopted and a notice of same shall be published according to law.

#### **COUNCIL INPUT**:

Councilman Martorelli stated that on July 22<sup>nd</sup> the Office of Emergency Management, along with the Township's emergency services, participated in a simulated drill of a plane crash. He further emphasized that the drill was a great accomplishment especially in knowing that the Township's emergency personnel could handle a crisis of such magnitude. Councilman Martorelli thanked the Department of Public Works, Police Department, and Fire Department for their quick response and cleanup during the recent storm. He encouraged residents to sign up for the Mayor's reverse 911 public service calls. Lastly, Councilman Martorelli thanked Novartis for sponsoring the summer concerts.

Councilman Brokaw congratulated the East Hanover Hurricane's Swim Team, and also, Coach Matt Villani for another successful season. He commended the Recreation Department and Department of Public Works for jobs well done during the summer concerts and the recent storm flooding. Councilman Brokaw applauded the Township's emergency services and neighboring fire departments at a recent fire that destroyed two railroad cars on Melanie Lane. He mentioned that East Hanover was very fortunate to have such dedicated employees and volunteers that handled back-to-back emergencies.

Councilwoman Jandoli likewise thanked Novartis for the great summer concerts as well as the Department of Public Works and all emergency responders for their services during the storm flooding and rail fire. She announced that the Farmer's Market was open on Mondays between 12:00 and 6:00 P.M. until October 30<sup>th</sup>.

Council President DeMaio elaborated on the success of the drill that took place on July  $22^{nd}$  where the Office of Emergency Management simulated a plane crash, and he believed that East Hanover was on the cutting edge of disaster preparedness. The Council President also
